Since our last meeting on April 28, 2024 the 31st Annual Golf outing was held at Tam O'Shanter golf club. Treasurer Farrar has prepared an Excel spreadsheet detailing the monies collected and spent by the Alumni Association associated with the golf outing. A copy of this spreadsheet can be obtained by contacting Treasurer Farrar.

At the high level the proceeds collected for the cost of the dinner cover all the cost associated with the dinner and the Hot Dog and Drink served at the turn for all golfers with an excess of \$89.90. Thank you to Brother Steve Pennell for again being the fund raiser for the 50/50 Raffle. Brother Pennell raised \$366.00 of which the winner, Brother Mason Pritchard, donated back to

the Alumni Association. With his donation, the entire \$366.00 has been deposited into the Alumni general Fund.

In addition, both the winners of the closet to the pin and longest drive contest donated their winning to the Alumni Association. Brother David Stotka winner of closet to the pin and Brother Luke Jordan with a super longest drive donated \$58.00 a piece that has been deposited into the Alumni General Fund.

There was an additional donation of \$100.00 made by Brother Gary Donelli for the purchase of a memorial brick for Brother Robert C. McGregor. This money was deposited into the Brick fund, but subsequently used to purchase the brick for Brother McGregor, following a motion and vote later in this board meeting.

The Board had previously approved the funds for the purchase of a brick for Brother Tom Hepler. The BOD has become aware that Brother Jack Shivetts had ordered and paid for this brick. With the BOD already approving the funding of the purchase of the brick the Treasurer will be sending a check to Brother Shivetts for reimbursement, which was voted on and approved later during this meeting.

To date the sales of "T" signs for the 2024 golf outing has collected \$600.00 that has been deposited into the General fund. The Following Brothers have purchased "T" signs and made the \$100.00 Donation

A total of \$1171.01 was raised from the 2024 golf outing and deposited in to the Alumni Board general fund.

Scholarship Fund Accounting The Helping Hand Scholarship.

The Treasurer requested a recap from the foundation of all proceeds and expenditures from the Helping Hand Fund during period of July 1, 2023 thru June 30, 2024. The University would not provide donors names at this time. I will work to see if we can get the requested information in an alternate method.

As of June 30, 2024 the balances are as follows:

Principle Account \$25,000 Interest Account \$ 7,422.56

It should be noted that there were no requests or expenditures for "helping Hand Awards" in the last twelve calendar months. The BOD has a standing approval for up to \$1,500 in awards per year. Because no awards were allocated last year the fund is able to allocate up to \$3,000 in awards for the next twelve calendar months.

As you can see below the investment activity and interest deposited \$931.22 into the Interest Account. All scholarship awards are paid from funds in the Interest account allowing the Principle endowed account to remain intact and accrue interest and investment income.
