#### **New Business**

#### **Brick Fund Reimbursment**

The BOD understands that in the past, the roster might not have always been accurate and men were likely initiated at a local level but weren't registered with IHQ.

Initiated Brothers Alan Lichtenwalner and Doug Espenlaub have vouched that these 3 men were a part of the local chapter during undergrad.

Following a brief discussion, the Board approved reimbursement for the 3 bricks that Brother Jack Shivetts purchased.

#### **Website Reimbursement**
