It will be a great time for older alumni to get to know the brothers!

### **After outing dinner and awards program.**

After the outing at approximately 6:00 p.m., everyone will gather at the **THETA CHI HOUSE at 115 Kiester Road, Slippery Rock, PA 16057** for awards, food and beverages including

presenting Golden Guard Certificates for 50 years of membership to attendees.

There is no end time for the event Saturday.

**Anyone not registered in advance access will not be permitted. The collegians are required by Theta Chi Fraternnity to have a participant list for any event where alchohol is served on hand for their protection.**

### Hotel

There are 6 Double Queen rooms reserved for June 12-14, 2026 at the Fairfield Inn & Suites by Marriott in Slippy Rock. The phone number for reservations is 724-406-0535 x #2.

Before you call to book a room, you can register (if not already a member) at **no cost** with the Marriott Bonvoy program. Go to <http://www.marriott.com>. In the upper right corner click the link "Sign in or Join." On the next screen click "Join for Free"

When the hotel is called and if you have a Marriott Bonvoy # tell the hotel this when reserving a room. If you are a Marriott Bonvoy member you will get a cheaper rate.

If you **ARE NOT** a Marriott Bonvy member the cost of the room for 2 nights is **\$463.98** (including tax.)

If you **ARE** a Marriott Bonvy member the cost of the room for 2 nights is **\$441.78** (including tax.)

Call the hotel and explain you are part of the **Theta Chi Fraternity Alumni Board Group** and you wish to reserve one of the rooms held by the block. At that time, the hotel will request a credit card to hold the room and an email address to confirm your reservation for your records.

Rooms will be sold on a **first-come-first served basis** and when gone they are gone.

If a room is reserved and a decision is made to cancel, the room must be cancelled before June 11, 2026 at 11:59 p.m. Otherwise the card provided will be charged for the reservation.

From that first outing, a tradition has grown which has endured for 34 years helping reunite our brothers yearly. It is normally the weekend before Father's Day in June (subject to facility conflicts) and is a date brothers add to their calendars. At the same time, we understand that life goes on and wih graduations, weddings and other family related matters one cannot always attend but brothers are comforted by knowing, if they cannot come this year, they can make it the next year!

### Interfraternity Council

Chapter President Jake Levy was elected President of the Interfraternity Council and Brother Mark Rose was elected as the Interfraternity Council Vice President of Education for 2026.

### Academics

Finals concluded on December 13, 2025. The Fall 2025 GPAs were recently released and the results are:

- There are 5 brothers who earned a 4.0 GPA - Zachary Bickel, Cole Clary, Johnny Grimm, Luke Jordan, Logan Pfaff.
- In addition to the above 5 brothers the following 13 brothers also made the Dean's List (3.5 to 4.0 GPA) - Evan Andrews, Daniel Babinsack, Adam Fisher, Connor Haney, Caleb Hankee, Nate Murrin, Blake Naeger, Jack Nalavenko, Michael Niness, Kaan Ozdemir, Thuta Htun, Nate Wagamen, Glenn Wilcox
- There were 14 other brothers who earned between a 3.0 and 3.49 GPA. That means out of 47 brothers 32 had a 3.0 or better!

### The average GPA for the Zeta Alpha Chapter for the Fall of 2025 - 3.084

- The all-men's student GPA average for Fall 2025 - 3.17, the all-fraternity student GPA average for Fall 2025 - 3.086.
- The all-women's student GPA average for Fall 2025 - 3.43, the all-sorority student GPA average for Fall 2025 - 3.482

All undergraduate average - 3.31

Theta Chi Fraternity in Fall 2025 held the 5th highest fraternity GPA with only a 0.216 point difference between 1st and 5th. This Fall Theta Chi was tied as the largest fraternity on campus with 47 members and stands only second to Pi Kappa Phi in academics with 47 members. The next largest fraternities on campus range from 9-24 members.

### Training

The Chapter President, Vice President, Health and Safety Vice President, Recruitment Chair and Marshal attended the January Officers Training Conference held in Indianapolis, IN, January 9-11, 2026, obtaining insight into their responsibilities, sharing information and networking with fellow brothers from all over the country.

### Spring Semester

- Classes were scheduled to begin again on January 20, 2026. However, as with many of you, experienced as well, Slippery Rock University closed for a couple days because of the snowstorm. Advisor Lehman met with the brothers on January 17th to check in, talk through a few behavioral items, hold a brief executive board meeting, and help map out the semester.

This visit happened just before the snow hit campus. With several classes moving online, the brothers leaned into the moment and stayed connected through some casual snow activities around the dorms and near the ski lodge.

- The chapter is expecting a large group of seniors preparing to graduate (approximately 10) which has naturally led to a bit of the "usual" senior disengagement. That said, the chapter remains tied as the largest organization on campus and continues to have a strong presence. To visit the current activities of the chapter, [click here](#).
- Recruitment officially kicked on February 1st. The chapter has planned seven events over the next two weeks, with a goal of bringing in between 10 and 20 new members.
- The chapter is planning to host a Founders Day Event on April 12 at 11:00 a.m. including a cookout, yard games and a variety of other activities. The chapter is enthusiastically invites alumni brothers to attend.
- The initiation of the Pi pledge class is scheduled for April 19, 2026. All initiated brothers are invited and appropriate suits and ties are required for admission. Time and location will be shared once everything is fully finalized.

## Alumni Board Actions

At the February 1, 2026 Alumni Board meeting, the following actions were taken:

- Approval of June 29, 2025 minutes.
- Verified the adoption of the bylaw amendment distributed in August passing by 95.24% to 4.76% margin to adjust the date to no later than May 15 each year to elect officers of the Board.
- Updated the signatory policy for Alumni Board general checking and brick fund savings accounts based on current banking requirements.
- Added the "official events" policy to Board Operating Policies. [Click here for the alphabetical list of Board Operating Policies](#)
- Began work on 2026-2028 Alumni Association Recognition Program application and designated representative to the convention.
- Authorization of the distribution of funds raised from the 2025 Golf Outing.
- Announced the Theta Chi Fraternity 170th Anniversary meeting and School of Fraternity Practices July 10-14, 2026 in San Antonio and selected Brother Krepinevich to be the designated delegate. All brothers alumni and collegiate are encouraged and welcome to attend.

- Discussed arrangements made so far for the Golf Outing and began working on specific details, fees and responsibilities for the event.
- Discussed the distribution and content of the February Alumni newsletter.

## What it costs to be a member of the Zeta Alpha Chapter of Theta Chi Fraternity

Many of us remember in the mid 70's and early 80's when a semester cost:

### In the 70's to attend Slippery Rock University

- \$360 for tuition per semester
- \$285 for a 14 week meal plan per semester
- \$287 for a dorm room per semester
- \$35 Student Activity Fee per semester
- \$0 for telephone that was a pay phone at the end of the hall.

**Total \$ 967.00 per semester**

### Theta Chi Fraternity Fees

A Theta Chi initiation fee was \$60

Once initiated the semi-annual fees for a brother were:

- National per capita tax - \$7.50 - \$17.50 per semester
- Rattle Fee - \$2.50 - \$5.00 per semester

**Total - \$10 - \$22.50 - per semester**

The chapter also charged local fees to cover programming, and other administrative responsibilities of \$10-\$25 per month a semester. (or a \$2 donation or at the door for parties!)

### 2026

But today things are significantly different and the brothers who have initiated into Theta Chi Fraternity in addition to the following:

### Currently, to attend Slippery Rock University

- Tuition - \$3,997 per semester
- Technology Fee - \$248 a semester
- Housing - \$3,684 per semester
- Fourteen week meal plan - \$1,766 a semester
- Student Activity fee - \$210 per semester
- Books - \$750 per semester

**Total \$10,655 per semester.**

### Theta Chi Fraternity Fees

A Theta Chi initiation fee is \$389.

Once initiated the semi-annual fees for a brother are:

- Programming and benefit fee - \$281 per semester (this includes liability insurance)
- Greek Bill Fee for payment processing - \$18



- Chapterspot Fee for chapter information management - About \$8 a member

### **Total - \$315 per semester**

The chapter also charges local fees to cover programming, and other administrative responsibilities of \$200 a semester.

It is clear the commitment the current collegians have made to be a member of the Zeta Alpha Chapter of Theta Chi Fraternity is obvious and some may say appropriate for the time. But from what we can see, it is the value the members perceive from those fees.

It is important that we are aware of and encourage their commitment.

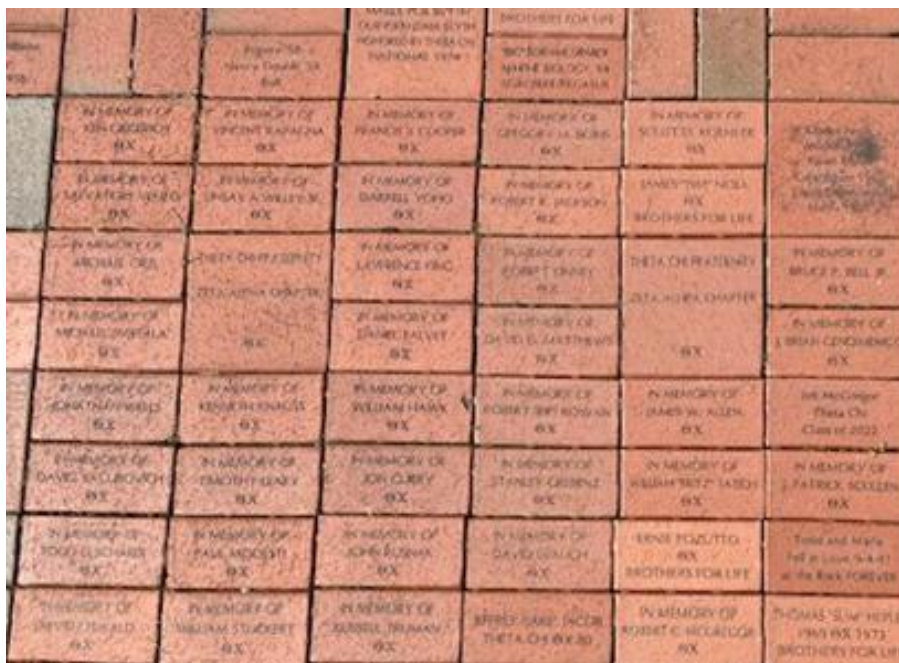
**Needless to say this deception has already placed bricks for brothers at this memorial who have NOT passed which is not consistent with the more than 45 bricks purchased in the past.**

## The Bonds of Brotherhood

Staying connected with Theta Chi Brothers was a much more difficult for those that may have graduated prior to the age of social media, email, text messaging, and facetime. Brothers would graduate, transfer, or leave Slippery Rock to transition to a full time job, get married, and then life started a new chapter in their life having no easy way of staying connected with their brothers and friends.

Many "experienced" brothers have been able to reconnect and find old friends that had meant so much to them as brothers while attending Slippery Rock. Thru the efforts of Brother Gary Sablowski, he and others have been able to reunite with Brother Rick Stafford. Rick pledge in 1973 and was a member of the Tau Pledge class while at Slippery Rock. Rick lived in the house, played on the intermural basketball team for Theta Chi and was a regular in pickup basketball games on the court in the back of the house. Rick graduated Slippery Rock with a degree in Special Education and returned to his hometown of Reading and started his career in Special Education. Rick worked as a special education teacher and helped coach youth basketball, which was one of his passions while attending Slippery Rock.

Thru unfortunate circumstances Rick suffered a severe stroke while driving, resulting in traumatic injuries that have confined him to a nursing home since the accident. Rick has been living in the confines of the nursing home for almost fifteen years. When Brother Sablowski finally located the nursing home Rick was living he contacted other Theta Chi Brothers that knew and loved Rick. They organized a visitation to the nursing home that had become home for Rick. These visitations have become a regular organized trip to spend time and brotherhood with Brother Stafford.

Brothers Heimerdinger, Young, Bradis, Sablowski, Debruno and others make the regular trips to visit Rick. They have helped Rick get an improved TV connection in his room adding a streaming box that allows Rick unlimited hours of sports entertainment. What appears as a small act of kindness gives great joy to Rick, as well as renews the bonds of Brotherhood for the brother making the visit in addition to giving great joy to Rick.



## Alumni Corporation Recognition Program Application for 2026-2028

Every biennium for the last 4 years Theta Chi Fraternity has required Alumni Associations to apply for and to obtain "official recognition." For the last 4 years the Zeta Alpha Alumni Association has been designated with official recognition.

To be eligible the association must:

- Be a non-profit. 501(c)(3).
- Be associated with a chapter for the benefit of the chapter.
- Identify an Alumni Delegate for the anniversary convention.

- Show incorporation with the state of Pennsylvania (Fictitious Name - DBA)
- File a 990-N tax filing with the IRS to maintain tax-exempt status.
- Have at least 3 directors on the Alumni Board.
- Ensure all board members are initiated members in good standing.
- Have an approved set of bylaws.
- Agree to and understand The Constitution and bylaws of Theta Chi Fraternity, Inc, the Safety Standards Manual, and Insurance manual.
- Confirm there are appropriate financial controls in place.

We have worked hard over the years and are proud to have insured that the Zeta Alpha Alumni Association in compliance.

The 2025-2026 Alumni Board has begun work in completing the application due by April 1, 2026.

When recognized, the following benefits will be received:

- License to use the Theta Chi Fraternity name and registered trademarks.
- Access to current roster and alumni contact information as available.
- Waiver of nomination fees for certificate-based awards
- Coverage under Theta Chi Fraternity's general liability and officers and directors insurance
- Ability to represent the alumni Association with a seat at the anniversary meeting of Theta Chi Fraternity

## Have you met MAX?





We have heard questions related to: "What is a dog doing on Theta Chi Rush shirts?" Well, there is an interesting story!

While the fraternity's official symbol is the rattlesnake, **Max the golden retriever** is the face of a modern lifestyle brand created by Theta Chi's official apparel partners.

The story behind Max and his presence on rush shirts is rooted in lifestyle marketing rather than historical lore:

### The "Retriever Collection":

Max was introduced as the central character for the Retriever Collection, a specific line of apparel designed to give Theta Chi a more approachable, "outdoor lifestyle" brand identity.

### A Marketing Persona:

Max is a purebred golden retriever depicted as a loyal "brother" who enjoys classic collegiate activities. He is often used to fuse the fraternity's image with other prestige brands, most notably in the Retriever Invitational shirts that mimic the Masters golf tournament logo.

### The "Resolute Men" Mascot:

His presence on recruitment (rush) shirts aligns with the fraternity's "Resolute Men" tagline. By using a golden retriever—a dog known for loyalty, friendliness, and high energy—chapters can project a welcoming, "best friend" vibe that appeals to potential new members.

### Official Symbols vs. Max:

While Max has become a "lifestyle mascot," the fraternity's National History and official Visual Standards remain tied to the rattlesnake and crossed swords originally adopted in 1856. Chapters/alumni designing rush shirts or printed materials are required to obtain approval from IHQ before generating to insure consistency in quality, content and compliance.

## SRU Residence Requirement



Though this was shared in the past, but it is important to remind everyone that on **August 9, 2022**, Slippery Rock University announced their Two--Year Residency Requirements.

The requirements include:

## **Who falls under the 2-year Residency Requirement?**

This requirement applies to all incoming First-Year, full-time students and continues through their Sophomore year.

## **Who is considered a First-Year and Second-Year student?**

A First-Year (Freshman) student is defined as any student who has completed less than 30 college credits. A Second-Year (Sophomore) student is defined as any student who has completed between 31 and 60 college credits. Students should expect to live on campus until they complete either four full-time semesters of college or successfully earned at least 60 credits.

## **Why did SRU create a two-year resident requirement?**

According to SRU, living in student housing gives students more opportunities to meet new people, discover new places, access campus resources and get involved with the SRU community. Research shows that residing on campus also leads to higher persistence and graduation rates and greater learning by maximizing opportunities for social and intellectual development from cocurricular activities.

## **This restricts off campus housing to Juniors and Seniors.**

Even with a chapter of 45, this limits the available brothers to fill a property. It also requires individual leases for each resident off campus. The Zeta Alpha Chapter looked at this situation over the last 2 years and have found a ways to accomodate and/or address the issue of the Zeta Alpha Chapter with a location where brothers can gather.

Based on brothers off campus housing interest and interest in living in the "Theta Chi" house, the chapter identified standards that can help them rotate brothers living in the house over years under these restrictions. It also maintains thier individual leases with the lessor without creating a need of non-Theta Chis to fill empty leases.

This past year, the chapter was able to mainatin a house with 7 brothers. Currently, that is the maximum that seems to meet interest/availability at this time. That is a good percentage considering only approximately 20 brothers any one semester are eligible.

No one other than the collegians should be making decisions about thier individual housing decisions and do not require anyone acting on thier behalf without thier prior permission.

## **Final Thought**
